

SABANCI UNIVERSITY BADMINTON CLUB REGULATIONS

I. Club Identity:

Item 1-

- a) The name of the club is Sabancı University Badminton Club.
- b) The club runs its activities centered in Sabancı University 8174 Orhanlı-Tuzla-İstanbul.

Item 2-

- a) The founder members of the club are former Sabancı University students; İdil Burcu Eren, İsmail Gökay Doğan and Hüseyin Tufan Usta.

II. The Purpose of the Club:

Item 3-

Badminton is one of the oldest and well-established sports, it has been continuing its activities at Sabancı University under the name of the Badminton Team since 2016. In order to make team activities more sustainable and to bring this sport together with more interested students, it was decided to continue its activities as a club in 2022. Under the name of Sabancı University Badminton Club;

- a) Contributing to the personal and social development of Sabancı University students and, more broadly, everyone who works with our club.
- b) To play an active role as students in raising students at Sabancı University as modern and versatile individuals.
- c) To create a team spirit and to develop the discipline of teamwork.
- d) To create and perpetuate the Sabancı University spirit
- e) Promote Sabancı University is aimed.

III. Club Activities

Item 4-

Sabancı University Badminton Club, in line with its aims and principles;

- a) Arranges trainings to train members that are interested in badminton, organizes tournaments among the school's students as well as other schools.
- b) Follows the works of national and international university clubs and other institutions, organizations operating in the fields of interest, ensures participation to the ones it deems appropriate, and carries out joint activities with them.
- c) Represents Sabancı University at national and international events and hosts it when necessary.
- d) Lays the groundwork for the exchange of ideas to diversify the activities and make them more useful.
- e) Organizes in-club trainings and programs for the development of club members.
- f) Organizes conference, conversation, panel, symposium, workshop etc.

IV. Club Membership

Item 5-

In order to be a member of Sabancı University Badminton Club;

- a) Being a Sabancı University student or employee,
- b) Filling the Club Membership Form,
- c) Comply with club rules,
- d) Club Membership Fee must be paid.

V. Membership Types

Item 6-

Members are divided into five: Members of the Board of Directors, Members of the Advisory Board, Active Members, Voluntary Members and Honorary Members.

Members of the Board of Directors: The Board of Directors consists of six members; It consists of a member unanimously elected from the previous year's Board Members by the previous year's Board Members, a member unanimously elected among the active members by the previous year's Board Members, and four members selected from among the active members by majority vote.

Advisory Board Members: The Advisory Board consists of three members elected from fourth year or graduate students. These members are; It is determined by the Members of the Board of Directors of the previous year.

Active Member: The member group consisting of students who are not on the Board of Directors. In order for students to become active members, they must participate in club activities in a qualified manner within a period. Qualified participation is measured on the basis of the member's contribution to the organization of activities, participation in activities or participation in other club-related activities. In the event that an existing active member does not participate in qualified participation, its active membership may be reduced by the Board of Directors or may be continued for a while with the initiative of the Board of Directors. In some special cases, for example, if the member participates in the student exchange program or freezes the registration, the memberships of the active members are frozen..

Voluntary Member: Member group consisting of Sabancı University employees. These members can take part in other activities, except for the events representing the University. They do not have the right to be elected. They can't vote, they can suggest an event, but they can't take responsibility for an event alone.

Honorary Member: Who does not meet the membership requirements, but contributes to events as a consultant
